Dear neighbors,

This Friday (April 1) you can go downtown for Fool Moon (illuminated puppets on parade). On Sunday (April 3) you can go to Main Street for Festifools (more giant dancing puppets). Any time this weekend you can do what I'm going to do - cut up my Christmas tree and get ready for the first compost pickup of the year.

Hooray for that, and how I wish it were warmer! It's supposed to warm up a little by the weekend, and I intend to spend Friday outside cleaning the garden and getting ready for that first truck of the year.

If you need compost, then you can get as much as 6 bushels (one cubic yard) of compost free using your own containers any Saturday between April 16 and May 28 from 8:00 am to noon, while supplies last (go to the *Materials Recovery Facility Scalehouse on Ellsworth*). Bring your current water bill and driver's license, please, to confirm that you are an Ann Arbor resident.

If you want to purchase compost or mulch, you can get it for ½ price if you've signed up for the Recyclebank program (at www.recyclebank.com). Compost and mulch are on sale starting in April for \$15/cubic yard.

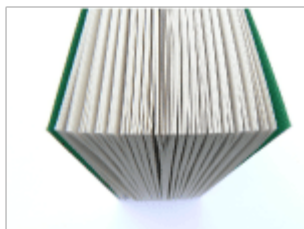
The City Administrator

was appointed to the search committee for an interim City Administrator as well as recommending a process for selecting a new City Administrator. I'm both surprised and honored to serve.

I'd love to hear from you about the specific strengths you would like Council members to look for in a new City Administrator (the City is run by the Administrator, not by the Mayor and Council). Right now my short list includes: management experience as well as private sector experience; skills managing people; decent financial oversight skills; strong communication skills; strong skills working with and negotiating with unions. A plus would be an ability to work with the Council and the community to develop a vision for Ann Arbor's future. The goal is to have someone in this position by late summer.

The Library Lot

Not a day goes by that I don't hear from someone about the proposal to build a conference center and hotel on the Library Lot. On the street, while I've stopped for coffee, at an event . . . casual conversation just turns to this topic. So does more directed conversation, as some people go out of their way to either call or write to make certain I know where they stand.

On March 14th the Council held a working session on the proposed Letter of Intent (LOI) with a representative from the Roxbury Group (the consultant). At that time, the City Administrator proposed that the Council vote on whether or not to accept a final version of the LOI on the 19th of April. Council member Rapundalo requested a public hearing be set for the 19th, as well.

At this time, I have no idea what the LOI would include. Certainly, it should not include all of the details (the parking, the financial structure) that were included in the draft LOI, as the Council learned that these details were still in negotiation.

The Council meeting for April 19th will be very crowded. In addition to the proposed LOI for the Library Lot - and the public hearing for that proposal - there will be *two* public hearings on medical marijuana. The medical marijuana zoning and licensing ordinances are both scheduled for final reading on that date.

In addition, the City Administrator will present the proposed budget to Council that night *and* the Council's search committee will present its recommendations for an interim appointment as well as the process for selecting and hiring a new City Administrator.

If you feel that this is an important meeting, I recommend either watching or recording (or both).

On the Agenda

The April 4th agenda is about as light as it can be, but as I write this (Thursday evening, March 30th) it is still subject to change. There are two public presentations (one is an update about 415 W. Washington). There are no public hearings. There is only one ordinance change proposed - a first reading - to amend the 'solicitation' ordinance regarding panhandling. Since I chaired the task force that recommended the changes proposed, I'm sponsoring this ordinance.

There is a resolution to approve an agreement with the Ann Arbor Transportation Authority (AATA) for the construction of the AATA Washtenaw Avenue east bound bus turnout project and another to award a construction contract to Fonson, Inc. (\$159,107.31; Bid No. 4131) to build the turnout:

The first resolution establishes a construction fund (\$237,107.31 total) with the City using funds from AATA; the other awards a contract using some of those funds. This bus turnout will replace the major bus stop that used to be at Arborland.

The total project cost is estimated at \$237,107.31 as shown below:

There are a few street closings (Art Fair and the Dexter/Ann

Arbor & Burns Park Runs). There are a couple of resolutions to buy used furniture, and a couple more accepting and giving easements.

Solicitation Ordinance revisions

The Mayor's Street Outreach Task Force recommended the following (red line) revisions to the Solicitation ordinance. The addition of paragraph 4 is to ensure safe, pedestrian passage between streets. The addition of a safety zone at the entrance of the downtown Library is to allow Library patrons the opportunity to enter and exit without harassment. Members of Council will see this recommendation on Monday, but should hold a public hearing and vote on the ordinance change no sooner than 30 days thereafter.

9:70.- Solicitation.

Except as otherwise provided in Chapters 79 and 81 of this Code, it shall be unlawful for any person to solicit the immediate payment of money or goods from another person, whether or not in exchange for goods, services, or other consideration, under any of the following circumstances:

1. On private property, except as otherwise permitted by Chapters 79 and 81, unless the solicitor has permission from the owner or occupant;
2. On any public transportation vehicle or public transportation facility;
3. In any public parking structure and within 12 feet of any entrance or exit to any public parking structure;
4. In any public alley and within 12 feet of any entrance or exit to any public alley, as that term is defined in Title I, Chapter 1, section 1:8 of the Ann Arbor City Code:
5. From a person who is in any vehicle on the street;
6. By obstructing the free passage of pedestrian or vehicle traffic;
7. Within 12 feet of a bank or automated teller machine;
8. By moving to within 2 feet of the person solicited, unless that person has indicated that he/she wishes to be solicited;
9. By following and continuing to solicit a person who walks away from the solicitor;
10. By knowingly making a false or misleading representation in the course of a solicitation;
11. In a manner that appears likely to cause a reasonable person

of ordinary sensibilities to feel intimidated, threatened or harassed;

12. Within 12 feet of the entrance to or exit from the Nickels Arcade, located between State Street and Maynard Street; the Galleria, located between S. University and the Forest Street parking structure; the Pratt Building, located between Main Street and the Ashley parking lot; [the Ann Arbor District Library](#),

13. From a person who is a patron at any outdoor cafe or restaurant.
